Kennedy received another of the legal profession's highest individual honors this year when he was given a "1" ranking in the Chambers USA 2010 listing of outstanding attorneys. Kennedy has been listed with a "1" ranking in the Chambers USA category of Litigation: General/Commercial in Nevada every year since 2003.

In addition to Dickey's work in complex civil litigation, he is a member of the State Bar of Nevada's disciplinary board and is on the editorial staff of the *Nevada Civil Practice Manual*.
