## Las Vegas Firm Ranks in Inc. 5000's Top U.S. Companies

Bailey Kennedy is only law firm in Nevada to make annual list

(Las Vegas, Nev.) Bailey Kennedy has been named among the country's fastest growing private companies in the Inc. 5000 annual list. Bailey Kennedy was the only law firm in Nevada that made the list and one of just seven companies from the Silver State.

The Inc. 5000 represents the most important segment of the American economy, independent minded entrepreneurs. Music website Pandora, convenience store chain 7-11, Brooklyn Brewery and Radio Flyer, maker of the iconic children's red wagon, are among the prominent brands featured on this year's list.

"The leaders of the companies on this year's Inc. 5000 have figured out how to grow their businesses during the longest recession since the Great Depression," said Inc. president Bob LaPointe. "The 2010 Inc. 5000 showcases a particularly hardy group of entrepreneurs." This year's Inc. 5000 companies employ a record 1.4 million people, up from one million on last year's list.

The 2010 Inc. 5000 is ranked according to percentage revenue growth when comparing 2006 to 2009. To qualify for this year's listing, companies must be based in the United States, privately held, for profit and independent. Companies must have been founded and generating revenue by June 30, 2006.
